JOB PURPOSE

- 10. Supervises the preparation of the annual and other periodic reports of the Directorate including the Regions.
- 11. Ensures the development and maintenance of registers of the Directorate.
- 12. Supervises the preparation of the budget of the Directorate including the Regions.
- 13. Supervises the implementation of performance management of the Directorate and the Regions.

- 15. Supervises the development and implementation of policies and guidelines on licensing, import and export control, post-marketing surveillance, inspection and enforcement.
- 16. Supervises the effective and efficient conduct of activities at the Airport, Seaport, Land Boarders and in the Regions.
- 17. Identify possible areas for research and improvement.
- 18. Supervises the close consultation with Directorates, officers and other stakeholders in the implementation of the programmes and activities of the Directorate.
- 19. Supervises the enforcement of medicines and related products Act 2014 and Medicines and Related Products Regulations 2020.

- 24. Participate in the development and maintenance of a quality management system of the Agency.
